

Minutes of Birbhum District Planning Committee Meeting held at the Conference Hall of Birbhum Zilla Parishad on 10/03/2010 at 11.30 P.M.

The Sabhadhipati, Birbhum Zilla Parishad and the Chairperson of Birbhum DPC presided over the meeting. Thereafter, agenda wise discussion was taken up and the following decisions were taken:-

1. Confirmation of the proceedings of the last held Birbhum DPC meeting (29.12.2009 at 12 noon)

The proceeding of the DPC meeting held on 29.12.2009 was read out before the members of the DPC present in the meeting for the benefit of the members and was also unanimously confirmed by the house.

2. Approval of BRGF perspective Plan for the year 2007-2008 to 2011-2012:-

The Annual Action Plan for BRGF 2010-2011 for Rs.2979.00 lakh (Rupees two thousand nine hundred seventy nine lakh) was placed in the meeting. A detailed discussion was made regarding different schemes taken up by ZP, PS, GP and Municipalities of this district. The proposal plan was approved unanimously for forwarding it to the Government for placement of fund at the earliest.

It has been decided only approved schemes should be executed. If any changes required out of approved schemes that must be placed before DPC for approval.

3. Preparation of District Plan:

Reg Annual Action Plan under District Plan it was reported by the that most of the Panchayat Bodies and Line Departments have not yet submitted their plan proposal. District Planning Officer was requested to contact with the Executive Officers of the Panchayat Samitis and Line Departments over phone for immediate submission of their proposals.

District Magistrate requested to ensure for supply of all papers including last meeting proceedings which would be discussed in the meeting prior to the date of meeting.
