

Minutes of the meeting in regard to Law & Order and Prosecution cases in the district held on 20.05.2011 in the Office Chamber of Addl. District Magistrate (Genl.), Birbhum at Prashasan Bhaban, Suri, Birbhum.

Amitava Sengupta, W.B.C.S. (Exe), A.D.M. (G), Birbhum presided over the meeting.

At the outset of the meeting A.D.M. (G) read out the previous meeting's minutes dated 15/03/2011 and feed back thereof.

A.D.M. (G) reviewed the performance report of the Asstt. P.P., Panel A.P.P who furnished their report for the month of January to April'2011.

Ld. P.P., Birbhum ensured that equal distribution of the cases among the Panel A.P.P.s have been made.

Ld. P.P. said that no sessions power conferred by the Govt. to the Addl. Sessions Judge, Bolpur and no Session Judge is also posted in the Dubrajpur Court till date which is very much required to dispose the sessions cases.

It is proposed by the Ld. P.P. and the Govt. Pleader that to remove the over burden of the Court and speedy disposal of the Electricity cases a separate Court is required to be formed. They also proposed that cases of Sadar Court relating to electricity may be distributed among other Judges with prior approval of the Ld. L.R., West Bengal and the matter may be discussed in the D.L.M.C. meeting.

It is further pointed out that presence of I.O. is very much important at the time of trial. In this connection, a workshop is also required with the Ld. P.P., Asstt. P.P.s and Panel A.P.P.s.

After discussion the following decisions were taken in the meeting:-


- 1) The Ld. District Judge, Birbhum may be requested in the next D.L.M.C. meeting in regard to posting of Addl. District Judge at Bolpur and the power of Asstt. District Judge, Bolpur may be obtained from the Judicial Deptt. or the Asstt. District Judge posted at Bolpur may be vested with the power of sitting in trial and sessions cases.

2) The Ld. District Judge will also be requested to take up the matter of filling up of vacancy of Dubrajpur Court and for set up a separate Court at Suri for quick disposal of the Electricity cases.

3) A workshop of I.O.s for Sadar and Bolpur Sub-division will be held on 11/06/2011 at 12:00 noon in the conference hall of Prashasan Bhaban, Suri and for Rampurhat Sub-division will be held on 25/06/2011 at 12:00 noon in the conference hall of S.D.O., Rampurhat. And in that workshop S.P., Birbhum, Ld. P.P., Birbhum, Asstt. P.P.s and Panel A.P.P.s of respective Sub-division, S.D.P.O.s, D.S.P. (HQ), all the C.I. of Police and all I.C.s / O.C.s of this district will remain present on their respective dates.

There is no other discussion, the meeting ended with a vote of thanks to and from the chair.
