1:0: Description of works: The particulars of nearly 40,000 no. of caste certificates since 1982 are required to be entered through VB.NET programme. For each case/ record nearly 17 no. of filed consisting of 4 fields to be selected from combo, are required to be filled up. The programme will be supplied by this end. The selected agency is required to enter data in their own computer in this office. No record will be allowed to take it out side the office. Once data entry work is completed, the data base to be handed over to the undersigned for printing and validation. After validation, necessary correction should be made to make the database error free. On completion of validation, the correct data base should be handed over to the undersigned in CD-ROM.

2:0: Source of fund: The bill of the data entry work shall be made out of 'contingency' fund of allotted to the SIDO. (Sadar) Suri.

3:0: Time Frame: The selected agency will be expected to complete the work as mentioned in paragraph 1:0 within one and half months from the date of placing the order which includes submission of total data base in soft copy for validation in full. The bill will be paid after necessary correction of the validated data.

4:0: Credentials: The intended agency should possess required work experience and possess due credentials.

5:0: Mode of application: The interested agency may offer rate in plain paper bearing their seal and signature, for work of data entry as mentioned in paragraph 1:0, under sealed cover along with attested copies of certificate in support of their credentials as mentioned in paragraph 4:0.




