Terms & Conditions :

- (1) The Earnest Money amounting to Rs. 3000/- (Rupees three thousand) only in the shape of Demand Draft of State Bank of India payable at Suri in favour of Executive Officer, Md.Bazar Panchayat Samiti shall be accepted. The Security of the unsuccessful participants shall be released immediately except 1st and 2nd highest bidder. The Security of the successful bidders shall be released after satisfactory completion of Auction for which a Certificate shall be issued by the Executive Officer. The Earnest Money must be deposited on the same day before the Auction of materials i.e. up to 12 noon positively. The Auction will be start at 3 P.M.
- (2) The intending bidders who deposit the Earnest money of Rs. 3000/- (Rs. Three thousand) only in the name of Executive Officer, Md.Bazar Panchayat Samiti will only be allowed to participate in the Auction.
- (3) The Bid will be closed in favour of highest bidder in each case. He will has to deposit 25% of the Bid amount in cash at the fall of hammer and balance 75% amount shall be deposited within 07 days from the date of acceptance of Auction Bid failing which deposit amount i.e. 25% shall be forfeited in each case.
- (4) The materials can be inspected on 11/6/2011 in the Godown of the office of the undersigned.
- (5) The delivery of materials shall be taken within 07(Seven) days after making full and final payment. In case the materials is not lifted within specified time, one percent on the auctioned amount penalty per day shall be charged for 07 days. Thereafter, the whole amount of earnest money will stand forfeited.
- (6) Materials shall be auctioned weight on "as is and where is" basis and the entire quantity of materials should be lifted.

- (7) The Competent Authority reserves the right to accept or reject any bid or withdraw Auction of Scrap without assigning any reason thereof.

- (10) Any person bidding on behalf of any firm shall have the authenticated proof of representative of the firm.
- (11) In the event of default, the breach of contract or non compliance of any of the terms and conditions of the agreement or for furnishing any wrong or incorrect information against the conditions of Agreement will take the bidder liable to a suitable action as will be decided by the Competent Authority.
- (12) The successful bidders who will be allotted the work of lifting scrap shall liable to pay any or all the fees, taxes as may be levied by Govt. for the Carrying thereof.
- (13) Security of 2nd highest bidder will be released after allotment of the work to the 1st highest bidder.
- (14) The materials shall be weighted at the Weighting Machine of this office.
- (15) The transportation for lifting and carriage the materials will be arranged by the agency at his own cost not extra payment will be allowed in this regard.


