The pre-qualification and bid documents duly filled in all respect may be sent in person or courier or through registered post or ordinary mail so as to reach this Division Office before 2.30 P.M. (as per office clock) on 24/03/2008. Any sealed cover of bid received after the time set forth will not be entertained and will be returned unopened. WBSRDA, Birbhum Division does not take any responsibility for the delay caused by the courier or postal authorities or the messenger whomsoever may be appropriate. Pre-qualification and bid document shall be purchased on written application up to 18/03/2008 during working days and working hours from this office division office by producing necessary non-refundable Bank Draft amounting to Rs. 10,000/- (Ten Thousand) towards the cost of tender documents in favour of "WBSRDA A/C PMGSY (Admn.) payable at Suri.

Both technical and financial documents will be opened on 24/03/2008 at 3.30 P.M. by the Executive Engineer, WBSRDA, Birbhum Division in presence of bidders present.

The financial bid document of the technically qualified bidders will be opened on same day at 3.30 P.M. and the other bid documents will be returned unopened. No separate intimation will be given for this, unless the above date is changed. In case of change of date, due intimation will be given in News dailies. No individual intimation will be given. Name of the qualified bidders will be displayed in the office notice board.

The Executive Engineer, WBSRDA, Birbhum Division reserves the right to reject or cancel any or all pre-qualification documents and bid document without assigning any reason whatsoever.

The eligibility criteria are given below

- 1) The applicant in the same name and style should have achieved annual turnover in any of the year over the last five years for 60% of the proposed contract for estimated amount of Rs. 200 lacs or less and 75% for estimated amount more than Rs. 200 lacs.
- 2) The applicant in the same name and style as prime contractor should have successfully completed at least one contract of same type of work at least one-third value of the proposed contract within the last 5 years.
- 3) The contractor should have sufficient technical manpower, tools and plants to complete the work.

- 4) The contractor should have necessary bid capacity to execute the work (Documentary evidence in proof of the above 3 items should be enclosed).
- 5) Trial Balance or Accounting sheet on the Turn over, debit, credit positions for the last five years (Audited).
- 6) Income Tax return should be submitted for last 5 years.
- 7) Sales Tax & Professional Tax clearance certificate & Pan Card (Xerox copy) should be furnished (Xerox Copy).

The amount of earnest money is 2% of the estimated cost of construction and routine maintenance for next 1 years.

All duties, taxes, royalties, cess, [including 1% cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Act, 1996], toll, taxes and other levies payable by the Contractor under the Contract to the State / Central Government for any other cause, shall be included in the rates, prices and total Bid price submitted by the bidder. 1% cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Welfare Cess Act, 1996 will be deducted from the running bills.

Time allowed for completion of the work is 3(Three) months from the date of issue of work order.

The intending bidders are requested to inspect the alignment of the proposed road before quoting their rates.
