NOTICE INVITING TENDER

Sealed percentage rate tenders are invited from resourceful, bonafied & experienced contractor having credential as specified below for the following works as per list published with this notice. The intending contractor should have credential of at least 60% of the similar nature of work value stated against each work in a single work order within last three financial years.

. Application for purchasing tender document will be received up to 31-05-2011 & permission to purchase tender document will be given by the undersigned up to 31-05-2011 after verification of document to be submitted along with application containing a) Related Credential of work with details work order, Completion certificate & Payment certificate. b) Technical personal & Company structure. c) Detailed machineries owned. d) VAT registration certificate. e) Income tax clearance Certificate (with copy of last return submitted to Dept. f) P.T. Clearance certificate. The Tender will be of **two bid System**, a) **Technical Bid** comprising of the above particulars in one envelope and b) **Financial Bid** comprising of signed SOQ supplied with the tender Document and the rate offered in terms of Percentage rate of the amount put to tender in another envelope. This two envelope will be put in a Single bigger envelope containing Name & Address of the bidder and the work Ref No. Tenderer must apply separately for three works as mentioned in Annexure-I attached with this Notice.

Tender Forms will be sold up to 31-05-11 in the working hours from Cash Section of this office. Tenders will be received up to 2.00 P.M on 01-06-11 and will be opened **on the same date at 2.30 P.M.** in presence of intending tenderers. 2% (Two percent) of the tender amount shall have to be deposited as Earnest Money only by Bank Draft and made in favour of District Magistrate, Birbhum payable to at **Suri**.

Tenders without Earnest Money will summarily be rejected. Tenderers shall have to write their names and addresses and name of work with SL. No. And N.I.T. No on the Envelopes otherwise the Envelops may not be opened at all. Quantity of any items may vary 20% for which no change of rate will be allowed. Tenderers should inspect the site and acquaint themselves with difficulties and peculiarities if any prevailing at sites and quote the rate accordingly. The authority reserves the right to accept or to reject any or all the tenders and to get part work done by the engaged contractors without assigning any reason.

The Basic condition of work shall be as follows:

- (1) Every prequalification document submitted for permission to purchase tender document should be self attested.
- (2) All materials like steel, cement, H.P. etc. will have to be procured by the contractor.
- (3) Difference cost & escalation charge of any material shall not be entertained.
- (4) Royalty, cess etc are to be paid by the contractor as per rule.
- (5) Payment will be made as per availability of fund.
- (6) All terms & conditions laid down in the tender form of Birbhum Zilla Parishad will be in force in contract of the construction.
- (7) The work will be technically supervised by the Engineers of SSSDA and payment will be made from this office.
