Application for purchasing tender document will be received up to 12.00 noon. on 07/03/08 & permission to purchase tender document will be given by the undersigned up to 4.00 p.m. on 10/03/08 after verification of prequalification document like credential document, Vat registration Certificate, Income Tax (with copy of return submitted to I.T. Dept.) & P.T. Clearance certificate etc. to be submitted with the application for tender.

Tender Forms will be sold up to 4.00 p.m. on 11/03/08 from Cash Section of this office. Tenders will be received up to 2.30 PM on 13/03/08 and will be opened **on the same date at 3.00 P.M.** in presence of intending tenderers. 2% (Two percent) of the tender amount shall have to be deposited as Earnest Money only by Bank Draft and made payable to "**Birbhum Zilla Parishad**" at **Suri**.

Tenders without Earnest Money will summarily be rejected. Tenderers shall have to write their names and addresses and name of work with SL. No. And N.I.T. No on the Envelopes otherwise the Envelops may not be opened at all. Quantity of any items may vary 20% for which no change of rate will be allowed. Tenderers should inspect the site and acquaint themselves with difficulties and peculiarities if any prevailing at sites and quote the rate accordingly. The authority reserves the right to accept or to reject any or all the tenders and to get part work done by the engaged contractors without assigning any reason.






