Tenders will be received up to **2.30 PM on 13/03/08** and will be opened **on the same date at 3.00 P.M.** in presence of intending tenderers. 2% (Two percent) of the tender amount shall have to be deposited as Earnest Money only by Bank Draft and made payable to "**Birbhum Zilla Parishad**" at **Suri**.

Tenders without Earnest Money will summarily be rejected. Tenderers shall have to write their names and addresses and name of work with SL. No. and N.I.T. No on the Envelopes otherwise the Envelopes may not be opened at all.


