In pursuance of G.O. No. 3351(19)/PN dt.7.7.2006, the retaining 10% entitlement fund of Panchayat Samiti Rs.13.77 lakh was lying in the F.T. Account of Birbhum Zilla Parishad. Out of the fund (Rs.6,82,100/- and Rs.1,23,900/-) = Rs.8,06,000.00 (Rupees Eight lakh six hundred) only has already been sanctioned time to time for house hold survey and computer training. The Balance portion i.e. (Rs.13.77 lakh - Rs.8.06 lakh) = Rs.5.71 lakh (Rupees Five lakh seventy one thousand) lying in the F.T. Account. The entire balance portion i.e. Rs. 5.71 Lakh is hereby sub-allotted to the Executive Officer of the Panchayat Samities concerned. The EOs are hereby directed to release fund to the SDOs of the respective Sub-division as per their requisition for meeting the cost of computer appliances and other trainings affairs.
