Sir,

I am directed to refer to your No.79/1F/SS dated 01.11.2010 on the
 above and to convey the views of this Department regarding this matter as
 following:-

- 1) It is proposed that at district level, one of the A.D.Ms, authorized by District Magistrate, may issue income certificate for the abovementioned scheme, after being satisfied about the income of the family of the candidate with such enquiry as deemed fit. Similarly, at Sub-Divisional level the S.D.O may be authorized to issue income certificate and at Block level the B.D.O may be authorized to issue income certificate.
- 2) In Kolkata Municipal Corporation area, M.A. Department may identify the authorities for issue of such income certificate.
